## **Privacy Policy**

PPPTV values your privacy and trust. We will never sell, trade or share your personal information with anyone else, nor send you mailings on behalf of other organizations . We will only share personal information if you have given us specific permission to do so. Any permission requested will be explicitly and obviously solicited.

PPPTV regards your online privacy as an important and serious matter. We have created this privacy statement in order to demonstrate our commitment to this issue. The following discloses our information gathering and dissemination practices for the PPPTV web site.

As PPPTV continues to develop, we may add new features, change the type of information we gather or the method by which it is gathered. ### **IP Addresses**

We will not use IP addresses when recording any feedback or polling you might offer. An IP address is a number assigned to the computer that is requesting a Web page from our site.
